INSTRUCTIONS: 1. Complete in blue or black ink or print completed form.

- 2. Submit the completed form to the Auto Dealer Services Division by mail, hand delivery, fax, or scan and email using the applicable address found in the top right corner of this form.
- 3. You must also submit the applicable dealer license fee under IC §9-32-8 (watercraft), IC §9-32-9 (salvage), or IC §9-32-11 (all other license types). A list of fees is available at <u>http://www.in.gov/sos/dealer/4257.htm</u>. Checks should be made payable to the Indiana Secretary of State. The fee does not need to be submitted simultaneously with the renewal, but your renewal cannot be processed until payment is made.
- 4. You must include proof of current bond and proof of current liability insurance or membership in a risk retention group under IC §9-32 -11-14 with your completed application.
- 5. This form cannot be used to update any dealer information. Changes in name, address, etc. must be submitted using the appropriate forms, available on the Division's website at <u>in.gov/sos/</u> or by calling our office at 317-234-7190.
- 6. To ensure accuracy, dealer license plate fees are invoiced separately from the dealer license fee. Please do not submit payment for dealer license plate fees until you have received the invoice. Dealer license plates cannot be renewed until payment is made, so timely submission of your renewal is advisable.
