The fee does not need to be submitted simultaneously with the renewal, but your renewal cannot be processed until payment is made.
 4. You must include proof of current bond and proof of current liability insurance or membership in a risk retention group under IC §9-32-11-14 with your completed application.
 5. This form cannot be used to update any dealer information. Changes in name, address, etc. must be submitted using the appropriate forms, available on the Division's website at in.gov/sos/ or by calling our office at 317-234-7190.
